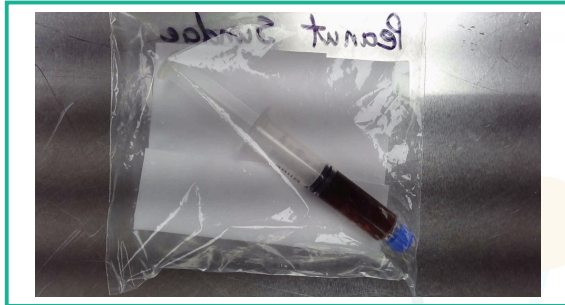

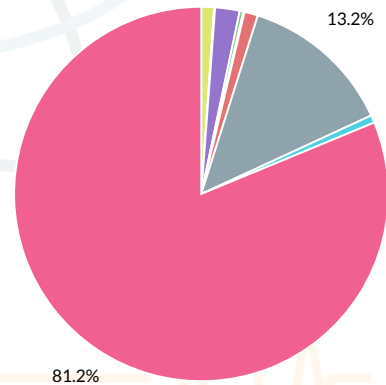

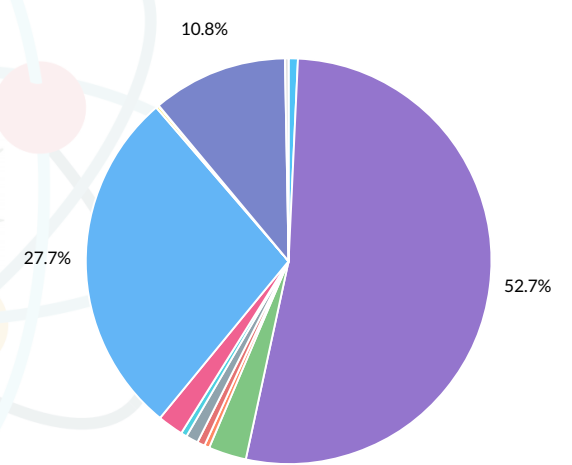

The collected data in this report is in accordance to ISO/IEC 17025:2017 guidelines and the data is generated using NIST reference standards and certified reference standards. The results of this report relates only to the materials or products analyzed and may not be reproduced without written consent from Scale Laboratories. Test results are confidential unless explicitly waived otherwise. This product has been tested by Scale Laboratories using valid testing methodologies and a quality system required by OMMA regulations. Uncertainty of the concentration is expressed as an expanded uncertainty in accordance with ISO 17025 and JGUM 100:2008 at the approximate 95% confidence interval using a coverage factor of $k = 2$ and has been calculated by statistical analysis of our production system and incorporates uncertainty of the NIST standards, pipettes, scales, environmental conditions, drift, solvent dispensers, method uncertainty, resolution and rounding.
