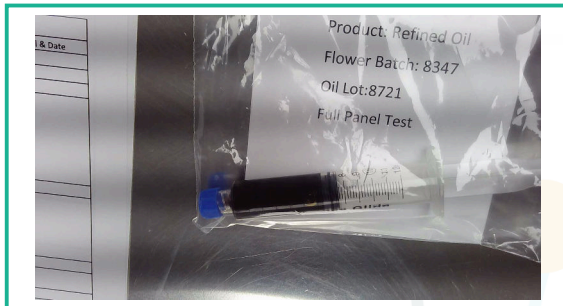

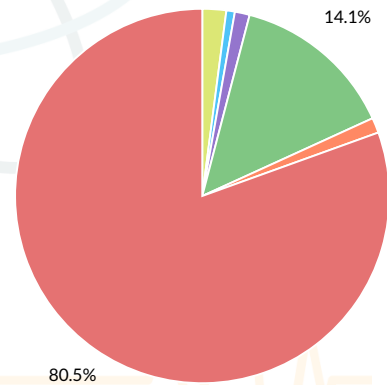

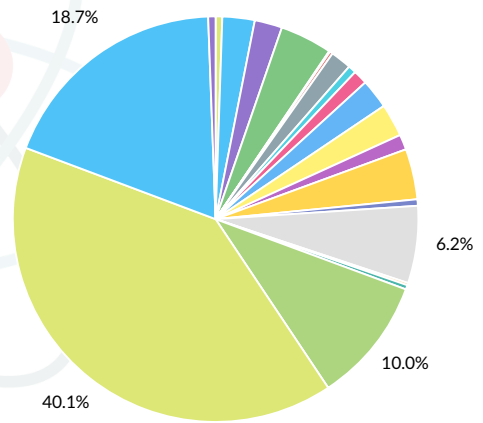

This product has been tested by Scale Laboratories using valid testing methodologies and a quality system required by OMMA regulations.
